Privacy Policy

PRIVACY POLICY

Maroy Foundation (“we”, “us” or “our”) values your privacy and the privacy of other visitors and users of our website at <http://maroyfoundation.com> (or successor URLs) (collectively, the “Maroy Foundation Site” or the “Site”). Our ongoing commitment to the protection of your privacy is essential to maintaining the relationship of trust that exists between Maroy Foundation and all of our users, whether they be donors, other NGOs (nongovernmental organisations), volunteers, registered users, readers of our newsletters or other visitors to the Site (collectively or individually “Users”). This notice of our Privacy Policy is intended to help you understand what information we gather from Users such as yourself, how we use that information and in some instances how we share that information. By using the Maroy Foundation Site, you expressly consent to the information handling practices described in this Privacy Policy.

THE INFORMATION WE COLLECT

User Submitted Information

You may provide to Maroy Foundation what is generally called “personally identifiable” information such as your name, physical or mailing address, e-mail address, personal/business/mobile telephone number, job title and employment history.

Cookies

Cookies are tiny text files that websites commonly write to your hard drive when you visit them so that they can remember you when you visit. Maroy Foundation may use both session cookies and persistent cookies. A persistent cookie remains after you close your browser and may be used by your browser on subsequent visits to the Maroy Foundation Site. By using these cookies, we can maintain your identity between sessions so that the Maroy Foundation Site can be personalised based on your preferences or history. These persistent types of cookies can be removed. Each web browser implements different functionality, so please refer to the manuals or technical support resources that are available in conjunction with your web browser to learn the correct way to modify your cookies set-up. Please note that disabling cookies may prevent you from accessing some of the functionality and site offerings available via the Maroy Foundation Site.

Automatically Collected Information

When you visit the Maroy Foundation Site or open one of our HTML emails, we may record certain information from your web browser by using different types of technology, including “clear gifs” or “web beacons.” This “automatically collected” information may include your Internet Protocol address (“IP Address”), web browser type, the web pages or sites that you visit just before or just after the Maroy Foundation Site, the pages you view on the Site, and the dates and times that you visit.

HOW WE USE INFORMATION

Maroy Foundation uses the information that we collect to provide you with all of the features and services found on the Maroy Foundation Site, including our volunteering and internship opportunities. We may use your submitted email address or other personally identifiable information in the following ways: (a) without further consent, for non-promotional or administrative purposes such as notifying you of Site updates; (b) to send promotional or fundraising messages, provided you have the opportunity to opt-out of receiving such messages; and (c) to provide you with our newsletters. We also use all of the information we collect from our Users: (a) for purposes of operating and maintaining the Maroy Foundation Site; (b) to understand usage trends and preferences; (c) to improve the way the Site works and looks; (d) to improve our promotional or fundraising efforts; (e) to create new features, content and functionality on the Site; and (f) to ensure that Users of the Site are abiding by our Terms of Service. We may use automatically collected information to: (a) remember your information so that you do not have to re-enter it during your visit or the next time you visit the Maroy Foundation Site; (b) monitor aggregate usage metrics such as total number of visitors and pages viewed; (c) provide custom, personalised content and information; and (d) monitor the effectiveness of our promotional and fundraising efforts.

WHEN WE DISCLOSE INFORMATION

In the event that you decide to volunteer or intern through the Site, we will share your information with other volunteers

or our NGO partners in order to facilitate these processes. In addition, you may opt in to us disclosing your information to other Users in the course of your participation in various features or services on the Site. We may also disclose any collected information to affiliated companies or third party businesses, organisations or persons to (a) process such information on our behalf; (b) provide website hosting and maintenance and security; (c) offer various features or services on the Maroy Foundation Site; (d) assist us in improving the way the Site works and looks; (e) deliver bulk communications; and (f) survey our Users. While we adhere to the statements set forth in this Privacy Policy with regard to your personally identifiable information, this Privacy Policy does not apply to, and we have no control over, and are not responsible for, the activities of any third party providers. We may share automatically collected and aggregate personally-identifiable information with interested third parties to assist them in understanding the usage patterns for certain content, services, advertisements, promotions and/or functionality on the Maroy Foundation Site. You will have the ability to opt-out in the event that we share your information with other third-party organisations for: (a) their promotional uses; or (b) any other programs or features not disclosed in this Privacy Policy. We may also share the information you provide to us if we reasonably believe that doing so is required by law or is in our interests to protect our property or other legal rights or the rights or property of others.

Third-Party Advertisers

Maroy Foundation may allow other companies, called third-party ad servers or ad networks, to serve advertisements within the Maroy Foundation Site. These third-party ad servers or ad networks may use technology to send, directly to your browser, the advertisements and links that appear within the Maroy Foundation Site. They may automatically receive your IP Address when this happens. They may also use other technologies (such as cookies, JavaScript or web beacons) to measure the effectiveness of their advertisements and to personalise their advertising content. Maroy Foundation does not provide any personally identifiable information to these third-party ad servers or ad networks without your consent or without granting you the opportunity to opt-out. However, please note that if an advertiser asks Maroy Foundation to show an advertisement to a certain audience or audience segment and you respond to that advertisement, the advertiser or ad-server may conclude that you fit the description of the audience they were trying to reach. You should consult the respective privacy policies of these third-party ad servers or ad networks as Maroy Foundation's Privacy Policy does not apply to, and we cannot control the activities of, such other advertisers or websites. Additionally, you can use the Network Advertising Initiative's ("NAI") opt-out tool here to change your cookie preferences with respect to NAI member advertisers.

CHILDREN

The Maroy Foundation Site is not targeted at children under the age of sixteen (16) and we do not knowingly collect personally identifiable information from anyone under the age of sixteen (16) without requiring parental consent. Any person who provides information to Maroy Foundation through the Maroy Foundation Site represents that they are 16 years of age or older. Some of these third parties may share or sell the information that they collect from you. Maroy Foundation is not responsible for the privacy practices of third parties. If you choose to visit or use any third-party products, sites or services, including those offered by our third party service providers or other partners, please be aware that this Privacy Policy will not apply to your activities or any information you disclose while using third-party products or services or otherwise interacting with any third parties.

SECURITY

No data transmissions over the Internet can be guaranteed to be 100% secure. Consequently, we cannot ensure or warrant the security of any information you transmit to us and you do so at your own risk. Once we receive your transmission, we make reasonable efforts to ensure security on our systems. We employ encryption and firewalls to protect your information from unauthorised access, disclosure, alteration or destruction. However, please note that this is not a guarantee that such information may not be accessed, disclosed, altered or destroyed by breach of such firewalls and secure server software.

By using the Maroy Foundation Site or providing personal information to us, you agree that we can communicate with you electronically regarding security, privacy and administrative issues relating to your use of the Maroy Foundation Site. If a security breach occurs, we may post a notice on the Maroy Foundation Site or send an email to you at any email address you may have provided to us. Depending on where you live, you may have a legal right to receive notice of a security breach in writing.
